## **Spot Admissions against Vacant Seats after AACCC special Mop-up Round 2025-26**

Datta Meghe Institute of Higher Education & Research (Deemed to be University) invites your kind attention to admission/counselling of vacant seats in UG Ayurved programs (BAMS), after the special Mop-Up round conducted by the Ayush Admissions Central Counselling Committee (AACCC) of Ministry of Ayush, Govt. of India, New Delhi.

### **FOR UNFILLED SEATS**

After the transfer of vacant seats to the Deemed to be University (Ref. No.1/1/2025-AACCC dated 13.01.2026) by the Ayush Admissions Central Counselling Committee (AACCC) for Final Institutional Round

#### **Eligibility Criteria:**

Candidates who are in the Final Offline Mop Up Round List, published in the AACCC website (<https://aaccc.gov.in/>) and have verified their credentials as Eligible for various Categories shall only be required to report for Spot Admission. In case the AACCC website publishes a second list the candidates eligible according to both lists, first and the extended can apply. No separate notice for the candidates appearing in the extended list shall be published.

#### **SPOT ADMISSION - SCHEDULE, PROCEDURE & INSTRUCTIONS:**

**Eligibility for Admission to vacant Seats:** Candidates in un-allotted list provided by AACCC for Final Offline Special Stray Vacancy Round.

**The Candidates interested in taking admission to the BAMS courses under Datta Meghe Institute of Higher Education & Research (Deemed to be University) should apply online to the Deemed University along with All India Rank and the percentile of marks obtained in NEET 2025. The online application form is available on website [www.mgachrc.org](http://www.mgachrc.org) from 19.01.2026 9.00 am till 19.01.2026 4.00 pm server time. The Deemed to be University shall formulate an inter-se- merit list on above basis.**

The said merit list will be referred to as DMIHER (Deemed to be University) UG Merit List-2025-26 herein after. The selection will be based on inter se merit of the candidates who shall report for counselling (First-come, first-served basis).

At the time of counselling, the candidate must physically appear for counselling in the chosen category from amongst the aforementioned options. Once the candidate is allotted a seat in a particular category, he/she shall not be eligible for further rounds of counselling and will have to stick to the allotted category only. No Change of category will be permitted at the time of admission under any circumstances.
